

┌ General conditions of sale

1. Application

The general conditions of sale apply in an exclusive way to the current and future trade existing between LMAC Boutique ("the salesman") and the author of the order ("the purchaser"). The present general conditions of sale can be modified constantly by the salesman subject revealing these modifications on the site.

2. Order

Any regularly place order will be taken into account by the salesman within the limit of his stocks available or subject to stocks available in its suppliers. In the event of unavailability of an article, the purchaser is informed within the shortest possible time by e-mail or mail. The informed purchaser of the unavailability of a product can cancel his order by addressing an e-mail or a mail to the salesman.

While filling and by validating the form of order, the purchaser accepts the entirety of these general conditions of sale placed at his disposal on the site, and admits having a perfect knowledge of it, renouncing of this fact to prevail itself of any contradictory document, and in particular of his own general conditions of purchase, the act of purchase involving acceptance of these general conditions of sale.

3. Execution order

The salesman is bound by the order which the purchaser places from acknowledgement sending of delivery confirming the acceptance of the salesman to treat this one.

The salesman reserves the right to subordinate the confirmation of order to other conditions, to suspend it or refuse it in the following cases limitedly enumerated:

- Incomplete or incorrect purchase orders;
- Obviously erroneous data communication;
- Non-payment of preceding deliveries or refusal of authorization on behalf of the bank or the financial organization of the purchaser;
- Orders relating to an abnormally high number of works;
- Orders relating to an abnormally high total amount;
- Delivery to be carried out in a geographical area where the risks would be unreasonable, either because of an unreliability of transport or distribution, or because of case of absolute necessity (wars, riots, strikes).;

The salesman sends to the purchaser an electronic mail of confirmation of his order as soon as possible. This confirmation includes/understands:

- References of the salesman;
- Details of the order;
- An extract of the methods of delivery;

4. Process of placing of order

After selection of the articles, the purchaser is invited to insert his co-ordinates and if need be, co-ordinates of invoicing of the order. After validation a summary of the personal data is posted, if these data are not correct, it can turn over to modify them. The purchaser can then select one of the modes of sending available (normal or recommended).

He is then asked to select a mode of payment:

- for the payments on line, the purchaser is redirected towards the platform of payment PayPal (information on [≤ https://www.paypal.com >](https://www.paypal.com)) which allows a protected critical datum processing. Once the payment carried out, a confirmation is indicated to the purchaser.
- for the differed payment, a form of confirmation of order is generated which will provide all information necessary to the sending of a transfer IBAN. The purchaser must take care to mention the n° reference of the order.

5. Prices

The prices indicated in euros are famous all inclusive of tax, except costs carriage. The salesman reserves the right to modify his prices constantly, but commits himself applying the tariffs in force which will have been indicated to the purchaser at the time of his order.

6. Expenses of sending

The expenses of sending which the purchaser will have to possibly support are communicated, on line, at the moment of the order. In a general way, they will be calculated according to a fixed amount by order, and of a variable amount depend on the number of articles composing this one.

The expenses of delivery are supported by the purchaser and are added, in the invoice, at the product price ordered.

7. Right of retraction

In accordance with the L.121-16 article and following of the Code of Consumption, the consumer has a 7 working days deadline as from the delivery date of his order, to turn over any article not agreeing to him and to ask the exchange or for refunding without penalty, except for the expenses of return.

This notification of the renunciation can be carried out by way of e-mail, fax or a mail recommended.

The reference of product concerned by the purchaser takes place in a 3 working days deadline of the sending of e-mail, fax or mail recommended of renunciation.

The salesman will refund, as of reception of the products send back the amount of the order concerned, in so far as the products concerned are perfect. The expenses of sending incurred to turn over the products sent back are supported by the safe purchaser in the event of delivery none in conformity.

The expenses of return in the event of retraction remain with the load of the customer.

8. Payment

9. Delivery

Except contrary provision, the delivery is made with the address that the purchaser indicated at the time of his order. The risks will be supported by the purchaser from the date on which the ordered products will have left the buildings of the salesman or his supplier. The delivery periods are only indicative except if, in exceptional circumstances, the salesman committed himself respecting a precise date of delivery.

10. Reserve of property

The delivered goods will remain our property until the purchaser filled all its obligations against the salesman and in particular until the integral payment of the price, if necessary increased interests. This reserve of property does not make obstacle with the transfer of the risks which will be supported by the purchaser from the date on which the ordered products will have left the buildings of the salesman or his supplier.

11. Guarantee of the hidden defects and responsibility

On the assumption that the products delivered by the salesman presents vice hidden, the salesman reserves the right, with his choice, to eliminate this vice or to replace the product vitiated by another.

The offered products are in conformity with the French legislation into force. The salesman declines any responsibility on the assumption that the delivered product would not respect the legislation of the country of delivery (censures, prohibition of an author or a book).

In the same way, the responsibility for the salesman could not be retained because of the contents of the sites to which the bonds hypertexts can return starting from the site of the salesman.

The responsibility for the salesman could not be retained in the event of failure with our contractual obligations because of a fortuitous occurrence or of a case of absolute necessity such as, and without limitation, the catastrophes, strikes, fires, floods, failure or breakdown of material, the communication, and means of transport or your intrigue.

Moreover, the responsibility for the salesman will not be committed in the event of delay due to an out-of-stock condition in the editor or the supplier nor in the event of error in the presentation of the products on our site, the photographs, texts and illustrations representing the products not being contractual.

12. Personal Data protection

The salesman respects and protects the private life. All the communicated personal data are treated in all confidentiality

The salesman collects personal information most quickly to treat the orders of the purchaser and most easily possible. This information will be also used to propose to the purchaser personalized services which will take account of its tastes and preferences.

The salesman respects the law relating to the protection of the life deprived in the processing the personal data implementing the European directive of October 24, 1995. This law provides that the assent of the person must be obtained before being able to collect personal data relating to it; that the personal data must be relevant, suitable and exact; and finally that they must be collected at specific ends, explicit and legitimate. The person of which the personal data are

13.Proof

Notwithstanding the other documentary evidences or all evidence preserved on another durable support to which access the purchaser will have, it is agreed that the computerized registers, preserved in the computerized systems of the salesman or his sheltered, could be worth like proof of the communications and the contents of the orders between the parts.

14.Intellectual rights

15.Applicable duty and court of jurisdiction

The present general conditions of sale are subjected to the French right and the Convention of Vienna on the international sale contracts of goods, other than the right of the sale of the United Nations. The courses and courts of Paris will be only qualified in the event of litigation.
